## **COOKIES**

The site uses exclusively cookies called as "strictly necessary", which do not require the prior consent of the user.



# THE SAMURAIS EXPLORER

These cookies are used to enable and facilitate navigation on the site, in particular by memorizing the user's navigation preferences, without identifying him / her personally, defined during his session, to facilitate access to the reserved spaces, and to realize anonymous statistics of use and visits.

On a technical point of view, these cookies cannot be disabled from the site. However, the user may oppose the use of these cookies, exclusively by setting his/her browser.
